**Sheriff's Office seeks reserve deputies**

Marshall County Iowa -

The Marshall County Sheriff's Office will begin testing for Reserve Deputy Sheriffs on 02/01/08. The Sheriff's Reserve Unit is a volunteer non-profit law enforcement organization. A reserve candidate must be at least 18yrs. of age. The individual must pass a physical agility test, a written comprehension test, and participate in one or more personal interviews. Also required is a complete background check including a polygraph for criminal offenses. The person cannot have any felony convictions. If accepted, the applicant will receive training in various facets of the law enforcement profession including but not limited to criminal and traffic laws, firearms, self defense and accident investigation. Each officer is required to volunteer 8 hrs. a month by patrolling with a deputy. The officer also must attend one combination business and training meeting a month. Officers share some of the training costs and are required to supply their own handgun and leather. Complete uniforms are provided. The reserve organization has been part of the Marshall County Sheriff's Office for over 30 years. Reserves will perform all types of law enforcement duties, including arrests, investigations, security of visiting dignitaries, natural disaster, and crowd control. Applications will be accepted until 5:00 PM on January 17, 08 or postmarked no later than January 16, 08. Office hours are 8:00 AM to 5:00 PM Monday - Friday.
