**Search Warrants Served July 29, 2009**

Marshall County - The Mid-Iowa Drug Task Force (MIDTF) and Mid-Iowa Narcotics Enforcement Task Force, MINE TF ( East division ) along with several other law enforcement agencies, served a total of 8 search warrants, on Wednesday, July 29, 2009. The investigation has resulted in two arrests so far.

Authorities served warrants at five residences in Marshalltown, at 311 Park St., 204 N. 15th St., 306 Summit St., apt. #2, 306 Melody Lane, apt. #1, and 1704 Edgebrook Drive, apt. #5.

A search warrant was also served at 301 Meskwaki Road, apt. #1 in Tama County, and at 426 Park St., in Grinnell. Authorities later served a search warrant on a car in Des Moines, at 1124 Vine St.

Two arrests were made in Marshalltown at 311 Park St., after a quantity of methamphetamine was found at the residence.

Arrested were:

Carlos Jara-Cruz, age 37, of 311 Park St., and Miguel Jara-Cruz, age 38, of 311 Park St.

Both men were charged with: Possession of a schedule II controlled substance with intent to Deliver, a Class B felony, Violation of the state Drug Tax Stamp, a Class D Felony, and Prohibited Acts, an aggravated misdemeanor. Both men were jailed on \$100,000.00.

Officers also seized a small amount of methamphetamine, a handgun, and additional documents evidence, at 204 N. 15th St. The remaining search warrants involved seizures of documents and motor vehicles. A total of six vehicles were impounded by authorities.

Additional arrests are pending as the case is yet under investigation.
