- Deputies respond to robbery in progress.

On October 14, 2016 at approximately 0724 hours, Marshall County Deputies were dispatched to a robbery in progress occurring in the 3000 mile of Main Street Road, Marshalltown Iowa. During a burglary to the residence suspects were interrupted when the property owner returned home. While the owner questioned one of the suspects on the property, a second suspect exited the residence and pointed a gun at the owner. The suspects ordered the owner to the ground and fled the scene at a high rate of speed in a dark colored passenger car. The unknown suspects were described as 2 Caucasian males 5'10 to 6'2 and in their 20's to early 30's.

The description of the vehicle used in this robbery matched the description of a vehicle that had been reported stolen to the Marshalltown Police Department a few hours prior to this incident.

When deputies arrived it was discovered multiple guns were stolen from the residence during this incident.

As the investigation progressed, the stolen vehicle was later located in Marshalltown by Marshalltown Police Officers in the 800 block of East Nevada street. The suspect vehicle was impounded for evidence processing.

Marshall County Sheriff's Office continues a joint investigation with the Marshalltown Police Department in both incidents.
