**MIDTF Serves Narcotic Search Warrant**

305 Edgewood Street, Marshalltown, Iowa -

On November 4, 2016 agents of the Mid-Iowa Drug Task Force served a narcotics search warrant at 305 Edgewood St. in Marshalltown, Iowa.

As a result of this investigation, four suspects were arrested and transported to the Marshall County Jail on various criminal drug charges:

Austin Charles Elliott, age 29, 2431 233rd St., Marshalltown

- Possession of Schedule I Controlled Substance (marijuana), serious misdemeanor.
- Possession of drug paraphernalia, simple misdemeanor

Brad Anthony Holloway Jr., age 25 1005 S 2nd St., Marshalltown

- Possession of Schedule I Controlled Substance (marijuana), serious misdemeanor.
- Possession of drug paraphernalia, simple misdemeanor

Malik Ali Spates, age 20, 714 Lincolnway, Marshalltown

- Possession of Schedule I Controlled Substance (marijuana), serious misdemeanor.
- Possession of drug paraphernalia, simple misdemeanor.

Tyson Bryant Peters, age 29, 305 Edgewood St., Marshalltown

- Possession of Schedule I Controlled Substance with intent to deliver –marijuana, D Felony
- Failure to affix a drug tax stamp, D Felony.

Officers seized marijuana, butane hash oil, prescription pills, one firearm with ammunition, and suspected psilocybin mushrooms as a result of the search warrant.

Additional arrests are pending as the investigation continues.

The Mid Iowa Drug Task Force was assisted with the execution of the search warrant by the Marshalltown Police Department and the Marshall County Sheriff's Office.
