**MIDTF Serves Narcotic Search Warrant**

110 N 4th St Marshalltown, Iowa -

On June 29th, 2017 agents with the Mid-Iowa Drug Task Force served a narcotics search warrant at 110 N 4th St. in Marshalltown, Iowa.

As a result of this investigation, four suspects were arrested and transported to the Marshall County Jail on various criminal drug charges:

Alphonze Emanuel, age 42, 110 N 4th St, Marshalltown

- Possession of Drug Paraphernalia, a simple misdemeanor
- Prohibited Acts, an aggravated Misdemeanor

Angel Pena, age 33, Marshalltown

- Possession of Schedule II Controlled Substance – Methamphetamine, 2nd or subsequent – aggravated misdemeanor.
- Possession of Drug Paraphernalia, a simple misdemeanor

Deralliac Lockett, age 39, 110 N 4th St, Marshalltown

- Possession of Schedule I Controlled Substance – Marijuana, a serious misdemeanor
- Possession of Drug Paraphernalia, a simple misdemeanor

Kristen Hernandez, age 28, 110 N 4th St, Marshalltown

- Possession of Schedule I Controlled Substance – Marijuana, a serious misdemeanor
- Possession of Drug Paraphernalia, a simple misdemeanor
- 2 counts of Child Endangerment, aggravated misdemeanors

Officers seized methamphetamine, marijuana, and drug paraphernalia as a result of the search warrant.

Due to evidence of drug use, drug sales, and poor living conditions in the residence MIDTF Investigators removed two children from the house.

Additional arrests are pending as the investigation continues.

The Mid Iowa Drug Task Force was assisted with the execution of the search warrant by the Marshalltown Police Department, Marshalltown SWAT, and the Marshall County Sheriff's Office.

The Mid-Iowa Drug Task Force is funded by a grant, through the United States Department of Justice, Bureau of Justice Assistance, and the Governor's Office of Drug Control Policy.
